



4S Ranch Little League is preparing to select players to field All-Star teams for participation in the Little League District All-Star Tournaments. Our league will form teams to compete in the 9/10, 10/11, Majors, and Juniors divisions.

The first step in the All-Star selection process is the completion of an eligibility and commitment agreement. Completing this form does not automatically place your child on an All-Star team, but it does make them eligible for consideration. Before determining if you would like to make your child eligible for All-Star consideration, please consider the following:

- 1) After making your child eligible for consideration their name will be placed on a ballot. A vote, of their peers and league managers/coaches, will then be conducted to select players to a team.
- 2) All-Star practices, team meetings and games must take priority over all other sports for the duration of the All-Star season. Unexcused absences may result in decreased playing time or removal from the roster.
- 3) The time commitment to an All-Star team is considerable. Teams can practice 6-7 days per week prior to the start of tournament play and several times per week as long as they remain in the tournament.
- 4) All-Star games, practices and team meetings may occur on any day of the week, including Sunday. Practices begin as early as June 3rd.
- 5) The District All-Star activities begin on June 17th and could continue into August. Games will be played on July 4.
- 6) If selected to an All-Star team, your child will be subject to Little League's tournament rules of minimum play. The rules state that a player must only receive one at bat to have participated in a game. Be aware that your child may only receive one at bat per game.
- 7) If selected, you will be asked to pay an \$85.00 registration fee. The fee covers the cost of your child's All-Star uniform (jersey, pants, socks, hat and practice jersey).
- 8) You must disclose any planned absences on your eligibility and commitment agreement that are scheduled between June 3rd and August 1st, 2017.
- 9) To be eligible for consideration your eligibility and consideration form must be returned via email to david.wheeler@4srll.com by **Thursday, April 27th**.
